Key Terms and Conditions

- 1 Two (2) month initiation period required upon first activation, on either the Plus or Unlimited plans.
- 2 The Basic Monthly and Basic Annual plans become eligible after the two (2) month initiation period.
- 3 All unused credits rollover to the next month and combine with monthly allocation. Rollover credits never expire.
- 4 Annual plans are billed monthly unless otherwise stated as pre-paid.

Additional Terms and Conditions

- 1 VARs may sell ACR Iridium Airtime Service under a contract between customer and ACR.
- 2 ACR will sell Bivy Airtime to VAR on a monthly basis and in turn VAR will have the ability to invoice the end user for the use of Bivy Airtime.
- 3 The parties agree that access to the Iridium Dealer Portal does not create a contractual relationship between Iridium and the VAR. VAR shall include in any agreement with the End User involving services, a provision that requires the VAR to give thirty (30) days written notice to any customer to who the VAR provides services before forcibly deactivating any such services. VAR shall also require any its dealers to flow down this requirement to all sub tiers that resell services provided by ACR to VARs under this agreement. If ACR determines,
- 4 in its sole discretion, that VAR has failed to require inclusion of the notice provision required under this section in such agreement or that sub-tiers failed to give the required thirty (30) days written notice before deactivating any service, in addition to any other rights and remedies that may be available to ACR under this Agreement or otherwise.
- 5 All plans will auto-renew until cancelled.
- 6 Cancellation of Annual plans prior to the two (2) month initiation period will be charged for the remaining months, plus an additional three (3) months at the Annual rate.
- 7 All billing for upgrading and downgrading of data plans will be billed at the beginning of each month.
- 8 A Fair Use Policy is applicable to the Unlimited plan and may be applied if the user overly exceeds the monthly average consumer usage.
- 9 Monitoring and dispatch is provided by Global Rescue for every active Bivy Stick account. A membership may be purchased through Global Rescue to pay for a potential rescue, however this is sperate from Bivy or ACR.
